### President's Corner: Convention Recap by Mary Frink

#### Day 1: Pre-convention Walk - Buffalo, WY

Buffalo is about a 2 ½ hour drive from Billings. I quickly discovered the down side of renting a car rather than being a bus trip passenger is that you have to drive instead of gawk at the scenery which was absolutely breathtaking! The walk on the Clear Creek Trail was supposed to be a quiet, wooded trail near the bottom of a ridge. However, all of the snow melt turned the creek into a raging river! Some of the trail flooded and we had to work our way around. I ran into Diane Bucher while she did the "back" of the "out and back" for the 10 km. She was there with Tater Tours. Great to see a familiar face!

### Day 2: Pre-convention Walk – Little Bighorn Battlefield National Monument. MT



The most surprising thing about Little Bighorn is how big it is! You hear about Custer's Last Stand and you only think of the hill. The battle took place over this huge amount of land. The walk went through only a small section of the battlefield. Scattered all over the area are these white marble markers denoting where a soldier fell. It's a little eerie when you come upon them and realize what they stand for. There are some red marble markers for prominent Native Americans who fell as well. There is also a veterans' cemetery like Arlington National Cemetery. It was an amazing place to walk. The visitor's center had tons of information & park rangers giving presentations all day.

### Day 3: Convention – Billings, MT



The first day of actual convention business! We started off with a walk from the convention center along the Yellowstone River. The Weather Channel reported flood watches on parts of the river and you could really see why! The river was very swollen. The walk followed the river and branched off to a small lake, circled the lake, then went back to the convention center. ### Trail Master's Diary: Colt State Park

Summer is officially here! Time for our favorite activities...trips to the beach, cookouts, walks, and picnics in the park. Walk 'n Mass Volkssport Club invites you to combine two of those fun things with 5km and 10km walk routes and our club picnic in a beautiful park...Colt State Park in Bristol, RI on July 29.

Colt State Park is referred to as the "gem" of the Rhode Island State Parks system. It features 464 acres of manicured lawns, flowering bushes, and fruit trees. The western border of the park features a spectacular shoreline along Narragansett Bay. It was originally the farm of Samuel P. Colt, a member of the Colt arms family and also of the wealthy DeWolf family of Rhode Island. Colt has an impressive resume, including terms as a state representative and Attorney General of Rhode Island. He also founded the Industrial Trust Company which later merged with Bank of America, and served as president of Uniroyal, the largest producer of rubber goods in the world. In 1905, he built a summer house on his farm, and a stone barn for his prized herd of Jersey cattle. The house was demolished in the 1960s, but the stone barn remains. The farm lands fell into disrepair after his death in 1921, until they were purchased by the State of Rhode Island in 1965 and dedicated as Colt State Park in 1968. As you drive in, note the statues of the bulls alongside the entrance. In all the years that I have visited the park, I never knew they are named Pomeroy and Conrad. Don't ask me which is which.

Both the 5km and 10km walk routes explore the beautiful shoreline, part of the four miles of bicycle trails that wind through the park, and one of my favorites, the picturesque Old Stone Bridge. The routes begin near the popular Chapel-By-The-Sea, before heading to a path alongside Narragansett Bay. Walkers will also pass by Colt's stone barn and over the bridge. Be sure to watch for wildlife near the bridge. I've spotted several egrets around there. The 5km route then returns back through the park to the finish and picnic. The 10km route continues along bicycle paths with spectacular views of Bristol Harbor. It then heads to the park's main road before going through the historic North Burial Ground with a tranquil cremation garden and large veteran's memorial. Walkers then head back to the main road and continue through the park before heading to the finish and food.

Both routes are flat and on mostly paved surfaces with some uneven areas. They have an AVA rating of 1B, doable for baby joggers, but difficult for wheelchairs. After you walk, join Walk 'n Mass for a picnic prepared by your fellow walkers & bring your favorite picnic food to share. Come to Colt State Park for beautiful 5km and 10km walks, stay to mingle, and enjoy some delicious food. Hope to see you on the trail on July 29!

The Anchorage Volkssport Club held a group walk on May 21 at Kincaid Park, a magnet for all sorts of sport activities year-round with several permanent trails. After signing in, the six hardy folk who came out on a wet spring afternoon started together. Both the 6 km and 10 km trails follow Margaux's Loop. Leaving the chalet car park, we crossed a footbridge and walked to Margaux Menaker Memorial Garden then followed the natural path trail winding up and down hills through woodland (white birch, cottonwood, and spruce). Just past the 5 km mark, Mike and Pam split from the group to continue on the 10 km.

We made our way to the Mize Loop. Before long we reached Viola Swamp where part of the trail was flooded. As recommended by the instructions, we bushwhacked our way to find a section of the trail above water. Luckily, we found a narrow animal track that led back to the Mize Loop just on the other side of the flooded section.

We didn't see much wildlife until we got to disc golf hole #11 where a trio of yearling moose was hanging out munching away on fresh greens. They seemed unconcerned about people or even the St. Bernard being walked nearby. Our next encounter, however, wasn't as benign. Just as we passed the Pia Margarethe Overlook, a moose cow crossed the trail ahead and went into the bushes. Presuming she was no threat, we continued walking a few more steps until she emerged on the trail about ten feet in front of us. We immediately stopped. Then her hackles went up and her ears laid back. Oh, crap.
