Trail Master's Diary: Springfield

As I'm writing this, it doesn't feel like spring, but it is here. The weather is bound to cooperate soon. When it does, celebrate spring's arrival at a walk in the park with Walk 'n Mass Volkssport Club. Not just any park...the Frederick Law Olmsted designed Forest Park in Springfield. Join us on May 12 for 6km and 10km walks in one of the largest urban municipal parks in the United States, covering 735 acres. Forest Park began in 1884 with 65 acres of land offered by Springfielder Orick Greenleaf. Shortly afterwards, wealthy philanthropist Everett Hosmer Barney donated an additional 178 acres. They convinced several of their wealthy friends and neighbors to donate the rest. In 1890, Barney built an elaborate 2 1/2 story Victorian mansion overlooking the Connecticut River and downtown Springfield. The mansion was razed in the mid 1950s when Route 91 was built. However, the carriage house (pictured below) still stands and serves as a restaurant and banquet hall. The mausoleum to Barney's son also remains.



Forest Park features typical Olmsted park elements including winding wooded trails and expansive views. You'll also find a zoo, aquatic gardens, an open amphitheater, playgrounds, baseball diamonds, and an ice rink. It is the site of America's first public municipal swimming pool.

After leaving the start point at Trinity United Methodist Church, the 6km route goes by tennis courts and continues over a bridge before passing the ice rink, splash pad, and pool. Walkers then follow along a ballfield before heading towards the zoo entrance (separate admission). If you want to visit, the

zoo features large cats, monkeys, and birds, among other species. The route continues on to a pretty covered bridge. After leaving the bridge, walkers will go around ponds, and cross a creek before heading to a wooded

path. The route then heads to a park entry road before passing by the tennis courts again on the way to the finish.

The 10km route heads into the woods after leaving the start. From there, walkers will pass by the spectacular carriage house, left over from the Barney estate. It continues to the mausoleum where there is an impressive overlook. Enjoy the view of the Connecticut River and part of the Springfield skyline. The 10km then travels over a bridge, up a hill, and to a park entry booth. There you'll see a statue by Peter Wolf Toth which is part of the Trail of the Whispering Giants. The statue represents Omiskanoagwiak (no, I don't know how to pronounce it), the Wolf-People Medicine Man. Walkers will then head to the covered bridge, around ponds, and by the Environmental Center. The route passes by the Zoo, the Senior Drop-In Center, and some gardens before heading to a ballfield and passing a stadium. It goes on to cross over a creek before heading back through the woods and entry road on the way to the finish.

Both routes have an AVA rating of 2B. They are mostly on paved routes with some natural paths. The 6km has one unpaved hill, while the 10km has one unpaved hill as well as some rolling terrain and paved hills. Neither route is doable for strollers or wheelchairs.

Celebrate spring and take a walk in the park with Walk 'n Mass on May 12 with 6km and 10km routes through Forest Park in Springfield. Hope to see you on the trail!

Ann Thibault and I arrived in Woodstock, Vermont the night before the Woodstock volkswalk where we overnighted at the Shire Motel located at the start of the village. We had a hearty breakfast at the cute little diner across the street from the Shire.

Our 10km walk started out cloudy with just a tweak of mist coming down. All too soon we started going up. Ann turned to me, surprised we were climbing. Unfortunately, we both wore sneakers. Soon we were tramping through mud, then Leo Bourque caught up to us, we introduced ourselves and continued up together. Both Ann and Leo had umbrellas.

At the top was a cute little bench seat – and then the rains came: no longer a mist, a deluge of rain, with no escaping. We decided to sit and wait it out until, we hoped, it stopped. There we sat, all tightly huddled, me in the middle with two umbrellas trying their best to shelter us. Shelter us yes, until the rains blew sideways! Thankfully, for our pitiful three, it finally became a trickle again.

We now headed down the other side which was not too bad. As it became steeper there was a wire to our right to grab if needed. That was reassuring until we came upon one troubled section where the wire was broken and the trail had a small muddy washout. Leo, who wore hiking boots, just jumped to the other side. If not for Leo's help we could well have fallen, but he coaxed us across with a strong hand and brought us to safety. Years later, we are still talking about this and Leo remains our hero: the hero of Woodstock's 10km volkswalk.




Photo Time: Fall River Group Walk
